CHARTER SCHOOL POLICY

HEALTH AND SAFETY

Applicability of Title Relating to Health and Safety

Universal Academy open-enrollment charter school is subject to a prohibition, restriction, or requirement, as applicable, imposed by Title 2 (Public Education) of the Texas Education Code, or a rule adopted under Title 2 (Public Education) of the Texas Education Code, relating to health and safety under Chapter 38 (Health and Safety), Texas Education Code. (TEC §12.104(b)(2)(K))

Universal Academy open-enrollment charter school adopts the requirements of Chapter 38 (Health and Safety), Texas Education Code pursuant to TEC §12.104(b)(2)(K).

Access to Medical Records

A school administrator, nurse, or teacher is entitled to access to a student's medical records maintained by Universal Academy open-enrollment charter school for reasons determined by policy, as follows: (TEC §38.009(a))

Student Information and Records Access

Who can Access Student Records

School administrators, nurses and eligible teachers can have access to student information and/or records for the purpose of a legitimate educational interest (see below) or access necessary to carry out their required job duties. School officials are entitled to access a student's educational or medical record information that is maintained by the school district only for purposes specified by this district policy. A school administrator, nurse or teacher who views student information or records under this policy shall maintain the confidentiality of those records and information.

Educational Information Access

The right of certain school administrators to access student information and records is justifiable if the access is considered to have a legitimate educational interest for the purpose of; a) serving the student; b) protecting the heath health, safety and learning of the student and others; c) maintaining the operations of the school district; **d)** obtaining payment for educational programs and services; and **e)** other purposes as specified by Federal and State law.

Health Record Access

School officials, including nurses and eligible teachers may access a student's health records without parental consent for the following instances; a) in an emergency when knowledge of the information is necessary to protect the health or safety of the student or other individuals; **b)** instances of suspected abuse or neglect; **c)** mandatory reporting of communicable diseases; d) information that is required by a school to which the student is transferring; and e) certain legal situations including subpoenas or investigations of criminal offences. This policy does not authorize a school administrator, nurse or teacher to require a student to be tested to determine the student's medical condition or status. (TEC §38.009(a))

A school administrator, nurse, or teacher who views medical records under this TEC §38.009 shall maintain the confidentiality of those medical records. (TEC §38.009(b))

TEC §38.009 does not authorize a school administrator, nurse, or teacher to require a student to be tested to determine the student's medical condition or status. (TEC §38.009(c))

Parental Access to Medical Records

A parent or guardian of a student is entitled to access to the student's medical records maintained by the school. (TEC §38.0095(a))

On request of a student's parent or guardian, the school shall provide a copy of the student's medical records to the parent or guardian. The school may not impose a charge for providing the copy that exceeds the charge authorized by Section 552.261, Government Code, for providing a copy of public information. (TEC §38.0095(b))

Referral to Outside Counselors

Universal Academy open-enrollment charter school or school employee may not refer a student to an outside counselor for care or treatment of a chemical dependency or an emotional or psychological condition unless the school:

1) obtains prior written consent for the referral from the student's parent;

2) discloses to the student's parent any relationship between the school and the outside counselor;

3) informs the student and the student's parent of any alternative public or private source of care or treatment reasonably available in the area;

4) requires the approval of appropriate school personnel before a student may be referred for care or treatment or before a referral is suggested as being warranted; and

5) specifically prohibits any disclosure of a student record that violates state or federal law.

(TEC §38.010(a))

In TEC $\S 38.010$, "parent" includes a managing conservator or guardian. (TEC $\S 38.010(b)$)

Implementation of Coordinated Health Program

Universal Academy open-enrollment charter school shall:

1) participate in appropriate training for the implementation of the program approved by the Texas Education Agency under Section 38.013 (Coordinated Health Program for Elementary, Middle and Junior

High School Students) designed to prevent obesity, cardiovascular

disease, and Type 2 diabetes; and

2) implement the program in each elementary school, middle school, and

junior high school.

(TEC §38.014(a))

Reporting of Certain Health and Safety Information

Universal Academy open-enrollment charter school shall provide to the agency information as required by the Commissioner, including statistics and

data, relating to student health and physical activity and information

described by TEC §28.004(k), presented in a form determined by the

Commissioner. (TEC §38.0141)

Care for Students At-Risk for Anaphylaxis

Universal Academy policies and guidelines includes:

Daily management of food allergies and allergen avoidance measures.

Strategic and easily accessible placement of medication.

Informing staff of all students who self-carry medications.

Training of school personnel in the administration of medications in accordance with governing

laws.

Work with the district's transportation department on: Emergency procedures.

Implementation of "no food or beverage sharing" policies.

Seat placement (while limiting potential for social isolation).

Share each student's emergency care action plan and other important information with school personnel.

Self-Administration of Prescription Asthma or Anaphylaxis Medicine by Students

For purposes of TEC §38.015:

- (1) "Parent" includes a person standing in parental relation.
- (2) "Self-administration of prescription asthma or anaphylaxis medicine" means a student's discretionary use of prescription asthma or anaphylaxis medicine.

(TEC §38.015(a))

A student with asthma or anaphylaxis is entitled to possess and selfadminister prescription asthma or anaphylaxis medicine while on school property or at a school-related event or activity if:

- 1) the prescription medicine has been prescribed for that student as indicated by the prescription label on the medicine;
- 2) the student has demonstrated to the student's physician or other licensed health care provider and the school nurse, if available, the skill level necessary to self-administer the prescription medication, including the use of any device required to administer the medication;
- 3) the self-administration is done in compliance with the prescription or written instructions from the student's physician or other licensed health care provider; and
- 4) a parent of the student provides to the school:
 - a. a written authorization, signed by the parent, for the student to self-administer the prescription medicine while on school property or at a school-related event or activity; and
 - b. a written statement from the student's physician or other licensed health care provider, signed by the physician or provider, that states:
 - i. that the student has asthma or anaphylaxis and is capable of self-administering the prescription medicine;

- ii. the name and purpose of the medicine;
- iii. the prescribed dosage for the medicine;
- iv. the times at which or circumstances under which the medicine may be administered; and
- v. the period for which the medicine is prescribed.

(TEC §38.015(b))

The physician's statement must be kept on file in the office of the school nurse of the school the student attends or, if there is not a school nurse, in the office of the principal of the school the student attends. §38.015(c))

TEC §38.015 does not:

- 1) waive any liability or immunity of a governmental unit or its officers or employees; or
- 2) create any liability for or a cause of action against a governmental unit or its officers or employees.

Psychotropic Drugs and Psychiatric Evaluations or Examinations

For purposes of TEC §38.016:

- 1) "Parent" includes a guardian or other person standing in parental relation
- 2) "Psychotropic drug" means a substance that is:
 - a. used in the diagnosis, treatment, or prevention of a disease or as a component of a medication; and
 - b. intended to have an altering effect on perception, emotion, or behavior.

(TEC §38.016(a))

Universal Academy open-enrollment charter school employees may not:

- 1) recommend that a student use a psychotropic drug; or
- 2) suggest any particular diagnosis; or

3) use the refusal by a parent to consent to administration of a psychotropic drug to a student or to a psychiatric evaluation or examination of a student as grounds, by itself, for prohibiting the child from attending a class or participating in a school-related activity.

(TEC §38.016(b))

TEC §38.016(b) does not:

- 1) prevent an appropriate referral under the child find system required under 20 U.S.C. Section 1412, as amended; or
- 2) prohibit a school employee who is a registered nurse, advanced nurse practitioner, physician, or certified or appropriately credentialed mental health professional from recommending that a child be evaluated by an appropriate medical practitioner; or
- 3) prohibit a school employee from discussing any aspect of a student's behavior or academic progress with the student's parent or another school employee.

(TEC §38.016(c))

Universal Academy open-enrollment charter school shall ensure implementation and enforcement of this TEC § 38.016 concerning psychotropic drugs and psychiatric evaluations or examinations.

An act in violation of TEC §38.016(b) does not override the immunity from personal liability granted in TEC §22.0511 (Immunity from Liability) or other law or the school's sovereign and governmental immunity. (TEC §38.016(e))

Serving Students with Diabetes

If a parent or guardian is seeking diabetic care for a student while at school, the physician responsible for the student's diabetes treatment must develop a diabetes management and treatment plan (DMTP). The DMTP must:

- 1) Identify the health-care services the student may receive at school;
- 2) Evaluate the student's ability to manage and level of understanding of the student's diabetes: and

3) Be signed by the parent or guardian and the physician. The parent or guardian must submit the DMTP to the school.

After a plan is submitted to the school, Universal Academy open-enrollment charter school must review the plan prior to the beginning of the school year, upon enrollment, or as soon as practicable following a diagnosis of diabetes for the student. (Texas Health and Safety Code §168.002)

Once the school receives the DMTP the nurse must develop an individualized health plan (IHP) for the student. The IHP must be developed in collaboration with the student's parent or guardian and, to the extent practicable, the physician responsible for the student's diabetes treatment and one or more of the student's teachers. A student's IHP must incorporate components of the student's DMTP, including the information required under Health and Safety Code 168.002(b) [see REQUIRED ELEMENTS, above]. (Texas Health and Safety Code §§168.001(3) and 168.003)

In accordance with the student's IHP, student is permitted to attend to the management and care of the student's diabetes, which may include:

- 1) Performing blood glucose level checks;
- 2) Administering insulin through the insulin delivery system the student uses:
- 3) Treating hypoglycemia and hyperglycemia;
- 4) Possessing on the student's person at any time any supplies or equipment necessary to monitor and care for the student's diabetes; and
- 5) Otherwise attending to the management and care of the student's diabetes in the classroom, in any area of the school or school grounds, or at any school-related activity.

(Texas Health and Safety Code §168.008)

Universal Academy open-enrollment charter school will ensure that a *school* nurse, trained individual or at least one unlicensed diabetes care assistant (UDCA)] is present and available to provide the required care to a student with diabetes during the regular school day.

Universal Academy open-enrollment charter school may not restrict the placement of a student with diabetes to a particular setting on the basis that the campus does not have the required personnel.

(Texas Health and Safety Code §168.007(c)–(d))

School-Based Health Centers

Universal Academy open-enrollment charter school may, if the school identifies the need, design a model in accordance with this Subchapter B (School-Based Health Centers), Chapter 38, Texas Education Code, for the delivery of cooperative health care programs for students and their families and may compete for grants awarded under this Subchapter B (School-Based Health Centers). The model may provide for the delivery of conventional health services and disease prevention of emerging health threats that are specific to the school. (TEC §38.051(a))
